INITIAL FACE TO FACE MEETING,

OR ZOOM OR FACETIME IF YOU ARE OUT OF THE WAIPĀ DISTRICT

- This is an opportunity for me to find out more about both of you. To gather information that I can use to write your unique ceremony and discuss the vision that you have for your wedding day.
- I'll provide a questionnaire for you to complete.
- I'll advise you of your responsibilities i.e. ordering the marriage licence, organising the venue, etc.

CEREMONY WRITING

- From the information you provide I will write your unique ceremony. Once it is drafted I will email you a copy to review. You can add, delete, or amend as necessary, and we will work together until you have the perfect ceremony.
- To be legally married in New Zealand is as simple as saying "I XX take you ZZ to be my wife/husband". Most couples like to follow this with their own personal vows. This is your opportunity to tell your partner how much you love them, what your plans are for the future together, what you love about them or what they do that annoys you! Your personal vows can be as long or as short as you want to make them and I'm here to support if you need a helping hand.

SECOND FACE TO FACE MEETING

- I like to do this as close to the wedding day as possible. It gives us an opportunity to go over everything and make sure we've dotted all the i's and crossed all the t's.

REHEARSAL

- Usually we try and do this at the venue within a week of the wedding date. It's great if we can get all, or most, of the bridal party along too. We run through the whole ceremony, including the music to walk in and out to, where to stand, where to sign the licence and the process for any rituals or readings, etc. That way when we get there on the day, everyone knows what they're doing.

THE WEDDING DAY

- I arrive at the venue approximately one hour before the ceremony is due to start. I'll catch up with the people involved with the ceremony: venue manager, photographer, MC, etc.


